

Ohio Schools Chromebook User Agreement for Students and Parents

All use of Chromebooks shall be consistent with the District's goal of promoting educational excellence. In order to align Chromebook use with that goal as well as positive behaviors, this document describes the expectations for students Chromebook use.

Be Responsible

- I will not apply any permanent marks, decorations, or modifications to the Chromebook.
- I will keep any/all identification barcodes on Chromebooks.
- I will only use the Chromebook to which I have been assigned, unless directed otherwise by a teacher or other staff member.
- I am responsible for the care and protection of the Chromebooks and will report any damage or malfunction immediately. I will not attempt to repair Chromebooks or gain access to the internal electronics.
- I will report the loss or theft of any Chromebook immediately, as waiting to report this will decrease the chance of recovering it.
- I will not expose Chromebooks to water or excessive heat or other environment that can damage the battery or electronics.
- I understand that if I can identify a security problem on the Chromebooks I will notify administration and not demonstrate the problem to other users.
- I will keep my account and password confidential.
- I will not use another individual's account without permission from that individual and Ohio Staff.

Be Productive

- During instructional time I will only access and utilize applications or websites to which I am directed or instructed either by my teacher or as required by my assignments.
- I will not use Chromebooks to engage academic dishonesty.
- I will not use the Chromebooks to access, submit, post, publish, or display any defamatory, inaccurate, abusive, obscene, profane, sexually oriented, threatening, racially offensive, harassing, or illegal material.

Be Respectful

- I will only utilize the Chromebooks in a manner that promotes positive, kind, respectful, and courteous interactions or communication between teachers, students, parents, or members of our community.
- I will make no attempt to harm or destroy hardware, software, or data of another user, the internet, or any other network.
- I understand that the Chromebooks are subject to inspection at any time without notice and remains the property of Ohio Schools.
- I understand that I will be liable for any damages incurred to the Chromebook.

Student's conduct is being evaluated by the District Staff, which includes, but is not limited to administrators, teachers, aides, coaches, chaperones, and bus drivers. All the aforementioned staff can make recommendations regarding whether or not a user has violated these expectations. The failure of any user to follow these expectations may result in that user privileges being denied, revoked, or suspended at any time. In the event of disciplinary action, completion of all classwork remains that responsibility of the student.
