V. <u>PRINCIPAL'S REPORT</u>

- 5.1 Attendance Update: Attendance for Grade School was down a little at 95.1.
- 5.2 School Report Card Update: Ohio Grade School District #17 received a Commendable Summative Designation. This goes to schools that have no underperforming student groups, a graduation rate greater than 67% and whose performance is not in the top 10% of schools statewide.

VI. SUPERINTENDENT REPORT

- 6.1 Enrollment: Pre-K thru 8: 86 students HS: 29 students TOTAL-115
- 6.2 Elections: Packets are due to the County Clerk's Office December 12th through December 19th. Courthouse hours are 8:00 AM until 4:00 PM. Make sure you have everything signed when you turn it in.
- 6.3 2023/2024 School Calendar: Typically, we approve the school calendar in December. Preliminary work has begun and a draft calendar has been submitted for teacher input. A tentative 23/24 calendar will be on a later agenda for Board approval.
- Fund Balance Review and Investments: We are currently receiving very low interest rates on our fund balances, so accounts are changing slightly and Dist 17 can take advantage of higher interest rates. The Midland account will move to a sweep account where the majority of our fund balances receive 3.01% interest (an increase of 2.75%). Additionally, \$500,000 has been moved to our account with Heartland Bank and will receive 3.25% interest which will pay out monthly.
- 6.5 December Meeting: In the past years the Board has canceled the December meeting due to limited items on the agenda. With Board approval, we will cancel this December meeting and if necessary, we will schedule an additional meeting to discuss any District business that arises.
